Change Order Description: Authorization of post-migration support services to supplement the existing MDCPS technical

support staff on a time-and-materials basis.

Reason for Change:

The Scope of Work authorized by the MACWIS Conversion Services SOW is nearing completion. On August 25, 2021, MDCPS provided a snapshot of the existing VB6-based MACWIS application to be converted. That baseline VB6 codebase has now been converted to a web-based .Net application per the SOW and is currently in User Acceptance Testing.

Specific reasons for this Change are as follows.

- Since the VB6 application baseline code was snapshot for conversion on August 25, 2021, there have been several changes made to the VB6 application by MDCPS which are now part of the production system. These changes have not been implemented in the converted web-based .Net application. Development, testing, and implementation of changes made to MACWIS after MDCPS creates the baseline code snapshot provided to HTC/Ciber for analysis and conversion was outside of the project scope per approved project deliverable, Deliverable 01 Project Management Plan v1.2, Section 2.2. Several of the changes made to MACWIS after the initial code snapshot are required for agency management directive, regulatory compliance, or court order. The changes may involve a revision to the workflow used by the MDCPS staff for case management. These changes will be required to be implemented and accepted in the migrated web-based .Net application prior to its introduction to the production environment.
- Training and Knowledge Transfer has been provided to the MDCPS IT support staff as reflected by
 approved project deliverable, Deliverable 07 Training Plan and Knowledge Transfer V1.0. However due
 to the continuous workload for other support responsibilities (including the Pathways project), the
 MDCPS IT support staff has expressed a desire for additional mentoring support be available to the
 MDCPS IT Support staff.
- 3. Per the RFP and the Knowledge Services Master Services Agreement, there is no warranty included. Bugs or issues identified following UAT acceptance will need to be addressed by the MDCPS IT Support staff or someone experienced with the converted application code base. Retaining a portion of the HTC/Ciber development and testing team would be beneficial to MDCPS capability and capacity to provide implementation support during go-live and production operation support for the converted application.
