Remove Milestone # 3: Resolution of the hanging issue that occurs 2 to 3 times a week in the Financial Module when "Add Request" button or "Add Commitment" button is selected. In various scenarios, Financial staff will select "Add Request" or "Add (\$18,570.00) Commitment" and at different times it will not allow the request or commitment to be added. The only way to resolve the issue currently is to re-boot the MUSTER application.

Remove Milestone # 4: Modification of 48 Word Templates <inserts> and alignment of <inserts> in Compliance and Enforcement Module letters to reduce the amount of (\$22,350.00) corrections needed to finalize the letters for mailing out.

Remove Milestone # 5: Correction of and updates to the existing stored procedures for the inspection checklist items in the Inspection Module:

- When dispenser terminations are registered as using Impressed Current, the checklist should be requesting a rectifier log, but it does not generate the auestion
- When piping is using electronic interstitial monitoring, requesting visual interstitial monitoring instead of electronic interstitial monitoring
- Add field "Compliance Manager" to inspection checklist
- Inspectors getting object errors when printing checklist
- Change Inspector Comment field where it does not allow special characters

Remove Milestone # 7: Resolution of deadlock issue – particularly in the C&E Module when two users are calling the same stored procedures and/or functions/views at the (\$15,970.00) same time.

Add Milestone 11: Resolution of the Runaway Fees issue. One of the stored procedures that occur in the nightly batch job is related to fees and it currently deletes some but not all records in the transfer table. It needs to be changed to delete all necessary records in the transfer table.

Add Milestone 12: Resolution of the Contractor Licensee issue. When the Company screen is opened, if a company is an Installer, the VB code that populates the screen doesn't acknowledge the new codes, and "unchecks" the Company Type Installer checkbox. Also, one of the main Crystal reports, "List of Companies By City And State," is not showing all the companies that are certified. In 2018, new licensee certification types were added to the already existing list in MUSTER, but those changes aren't reflected in the report. The Licensee Certification Type Names were changed for Installers and Closers and that caused a malfunction in the Company screen and Crystal report. Finally, there is an issue with the Compliance Manager screen.
